

## INDEPENDENT AUDITOR'S REPORT

### TO THE BOARD OF DIRECTORS OF OSEASPRE CONSULTANTS LIMITED

#### Report on the audit of the Financial Results

#### Opinion

We have audited the accompanying financial results of **Oseaspre Consultants Limited** ("the Company") for the quarter ended 31<sup>st</sup> March 2021 and the year to date results for the period 1<sup>st</sup> April 2020 to 31<sup>st</sup> March 2021 ("the financial results") attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("the Listing Regulations").
