
**To the Board of Directors of Oseaspre Consultants Limited**

1. We have reviewed the accompanying statement of unaudited financial results of **Oseaspre Consultants Limited** ('the Company') for the quarter and half year ended September 30, 2023, together with the notes thereon ('the Statement' attached herewith).
